We can extend funding to all West African countries and these types of institutions: research institutes, universities, public sector, and/or NGOs. We will reserve our funding to African partners, and hope that European partners can be covered by the other national funders.</p> <p>While the call requires that the project be led by an African project leader, applications must technically be submitted by a Norwegian institution.
